## Release, Indemnity and Assumption of Risks Agreement

This Release, Indemnity and Assumption of Risks Agreement is executed by the undersigned on the date set forth below.

WHEREAS, the undersigned has been invited onto the Rains Ranch located in Kimble County, Texas (hereinafter the "Ranch"); and

WHEREAS, as a condition to the undersigned being invited onto the Ranch, the undersigned has agreed to execute this Release, Indemnity and Assumption of Risks Agreement.

NOW THEREFORE, the undersigned agrees as follows:

1. *Assumption of Risks*, THE UNDERSIGNED ACKNOWLEDGES THAT (a) DANGEROUS NATURAL OR MAN-MADE CONDITIONS MAY EXIST OR OCCUR ON THE RANCH, INCLUDING STREAMS AND RIVERS WITH CURRENTS AND WATER THAT MAY BE DEEP OR FLOOD, HAZARDOUS DRIVING AND WALKING CONDITIONS, UNEVEN TERRAN, THE PRESENCE OF WILD, DOMESTIC, POISONOUS, OR DISEASED ANIMALS, ELEVATED HUNTING STANDS, AND/OR CAMOUFLAGED SUNKEN HUNTING BLINDS; AND (b) PARTICIPATING IN THE OUTDOOR WOMEN GONE WILD PROGRAM IS AN INHERENTLY DANGEROUS ACTIVITY INVOLVING THE USE OF FIREARMS AND OTHER LETHAL IMPLEMENTS AND THE PRESENCE OF OTHER PEOPLE, THE UNDERSIGNED ASSUMES ALL SUCH DANGERS AND RISKS.

2. *Indemnity*, THE UNDERSIGNED WILL INDEMNIFY, DEFEND, AND HOLD RONALD D. RAINS, THE RAINS FAMILY LIMITED PARTNERSHIP, AND RAINS MANAGEMENT, INC. AND THEIR AGENTS, EMPLOYEES, INVITEES, LICENSEES, OR VISITORS (COLLECTIVELY "LAND OWNER") HARMLESS AGAINST ALL CLAIMS, DAMAGES, AND COSTS (COLLECTIVELY "CLAIMS") INCURRED BY OR ALLEGED AGAINST LAND OWNER AND ARISING OUT OF OR RELATING TO ANY ACT OR OMISSION OF THE UNDERSIGNED OR ANY OF THE UNDERSIGNED'S AGENTS, EMPLOYEES, CON-TRACTORS, LICENSEES, OR VISITORS (COLLECTIVELY "PROGRAM PARTICIPANT") WHILE AT THE RANCH, INCLUDING ANY CLAIMS BASED ON ANY (a) INJURY OR DEATH OF ANY PERSON(S), (b) DAMAGE TO OR LOSS OF PROPERTY, OR (c) FAILURE OF PROGRAM PARTICIPANT TO COMPLY WITH ANY APPLICABLE LAWS.

3. *Release*, THE UNDERSIGNED WAIVES ALL CLAIMS AGAINST LAND OWNER AND RELEASES LAND OWNER FROM ANY LIABILITY, BASED ON ANY (a) INJURY TO OR DEATH OF PROGRAM PARTICIPANT OR (b) DAMAGE TO OR LOSS OF ANY PROPERTY BELONGING TO PROGRAM PARTICIPANT.

4. *Negligence of Land Owner*, THE FOREGOING INDEMNITIES, WAIVERS, AND RELEASES WILL APPLY EVEN IF THE INCIDENT GIVING RISE TO THE CLAIM IS CAUSED IN WHOLE OR IN PART BY THE CONDITION OF THE RANCH OE BY THE SOLE OR CONCURRENT ORDINARY NEGLIGENCE OF LAND OWNER (BUT NOT THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF LAND OWNER).
